#### Water Meter Issues



Due to software glitches, the **April** water reading were based on estimates. Then in **May**, the misreading was due to human error. **June** meter reads were performed by board members and those readings will reflect only the basic water rates, regardless of what the water meter read was.

#### **Roadside Ditches**



Thurston County Public Works recently informed us that the county will no longer regularly maintain these areas within our community. County maintenance will occur only two times per year, in the spring and fall. The roadside ditches within the public right of way shall be the sole responsibility of the homeowner / property owners. Last week we received confirmation Thurston County Public Works will not be mowing the ditches 2 times a year.

# **Dog Poop Stations**



Three more dog poop stations have been ordered and will be installed within a couple of weeks. The boxes are at no cost, but please consider using the dog poop bags wisely. Your HOA spends approximately \$1,000.00 per year on just the bags. The bags need to be taken home and disposed of. Please don't leave them for others to pickup as no one wants this job.

One station will be located at the ball field by the corner of Trevue and Scott Creek Dr and one will by the foot bridge over the creek and the last one will be placed by the tennis courts.

Speaking of poop, we have tried some different things to deter the geese from pooping at the shoreline. The Drainage District has moved forward with relocation of the geese, but no timeline from the Federal Government has been given yet.
