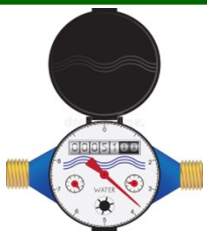

WATER COMMITTEE

Booster Pump replacement at the upper booster pump station, purchased a spare for the upper booster station, replace the two old booster pumps in the lower booster pump station adjacent to the concrete reservoir, go through those two pumps and replace gaskets with the thought that they would be useable as spares for the lower booster pump station.

The lead time is approximately 3-4 weeks, plus a couple of weeks for them to trim the impellers as needed for each booster station. Then they will schedule their installation. Because of timing, hot weather coming, being able to tag on to a recent order American Pump put in today rather than waiting for their next order to go in. It seemed prudent to give the go ahead and put the order in, so I did.

This is a capital expense, we would be billed when the work is done, so about the end of June.
