July 4th Parks and Recreation-If you plan to celebrate the 4th of July in the park, follow these rules:

Scott Lake Park is private property.

Residents and Guests (accompanied by a resident) only.

No alcohol in the park. This is state law: RCW 66.44.100

No illegal fireworks may be set off in the park. Thurston County can and does ban fireworks during extreme fire risk conditions. We will always follow the most updated regulations given by the county. Fireworks are ONLY allowed in the designated areas. These will be marked off and are within 15 feet of the shoreline. Absolutely NO fireworks on the docks or near the play equipment. This includes sparklers. These areas will be marked as closed. NO fireworks under trees. Always be aware of the potential fire hazards surrounding you before setting off any fireworks. Again, fireworks are ONLY allowed in the designated areas near the shore.

Hoses will be available in the park. Always follow the safety rules printed on your fireworks. Be aware and respectful of other park visitors. Clean up after yourself. Extra trash bags and dumpsters will be available.

If anyone is able to help with set up on the morning of the 4th or clean up on the 5th, contact office@scottlake.net

We ask the community to follow the: see something-say something rule. If you see someone breaking the law, endangering individuals, or endangering community property, please contact the authorities.
