## WINTER IS COMING SOON!

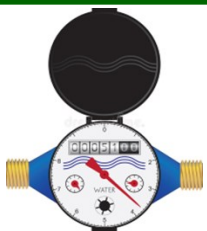

The Water Committee is continuing to work on different issues associated with the water system, including updating our Water rules and policies, improving our record keeping, working with the Office and Treasurer on our financial practices, Etc.
