Hello from the SLMC Board of Trustees Treasurer! In case you don't know me, my name is Judy Zygar and I am your Treasurer. I would like to share some of the things our financial team has been working on.

At present we have been working with RCAC (Rural Community Assistance Corporation), a non-profit organization that provides training, technical and financial resources and advocacy so rural communities can achieve their goals. RCAC has provided us with valuable information on bringing our Quick Books accounts in order using best accounting practices, separating our Water operations from our Non-Water (HOA) operations. Our Water Chairperson, Theresa Parsons and the Water Committee, the Financial Committee and our Executive Secretary, Penny Dorr have all contributed to creating a comprehensive financial plan for the financial security of the resources that make up the Scott Lake Community.

The SLMC Board of Trustees has also retained a certified financial advisor, Pillar Financial Group, to manage our reserves for future projects, most importantly, our aging water system.

Due to the overhaul of our QuickBooks, we have not posted any Profit and Loss statements because we need to completely separate our books into Water and Non-Water (HOA) to have accurate reports to provide to the community. We are close to completing that process and ask for your patience as we finish this process.

General Information about our water system:

- Over 5.5 miles of pipe
- 4 wells
- One water treatment building that uses calcite to neutralize the ph of the water and reduce corrosiveness.
- 2 reservoirs
- 2 booster pump stations
- Parts of the water system were installed in early 1960's

The WA State Depart. of Health requires that we have a certified water operator responsible for the oversight and operations of all water systems of our size. SLMC has contracted with Northwest Water Systems (NWS) to provide that service and the billing.

SLMC and the Water Committee are continuing to move forward with capital projects that help the operation and management of the water system while also moving forward with a strategy to replace the parts of our system that are past their useful life. It took years of delayed and deferred improvements and funding for our aging system to get where we are, and it will take time to move forward with the necessary major projects.

On the positive side, our water system is in substantial compliance with DOH regulations and operates under a green permit status. We are required to have an operating permit from DOH and they use the operating permit as a tool to protect public health by ensuring a system's drinking water is safe and reliable. Green is the highest of a Green, Yellow, Blue, Red rating system. This means even though we have some issues, such as with discolored water, DOH finds our system meeting their requirements.

We are building the reserves necessary to have in place for seeking additional funding for projects and we are overhauling the financial accounting system to help us comply with standard accounting practices.

Please be aware that the SLMC owns the water system and the water services from the main up to the meter. From the meter on to private property, the service is owned by the property owner and the property owner is responsible for any repairs past the meter.
