Annual Meeting Results

On Saturday, May 10th, Vice President Tom Culleton called the Annual Meeting to order. While the Election Committee verified and counted the votes, the board shared the accomplishments from the past year. Here are just a few:

- Replaced 150 water meters with radio-read meters.
- Upgraded the community center by replacing the flooring, inner and outer doors, and ensuring the bathrooms are ADA compliant. The interior has also been completely painted.
- Installed a cover over the sharing table.
- The Events Committee organized several events, including the Easter Egg Dash, Pictures with Santa, Bunko, a Pumpkin Carving Contest, and National Night Out with Music in the Park (held in August).

Theresa Parsons introduced Alaine Shuemann and Suzanne Fromme, the Co-Supervisors of the Elections. Alaine explained that, according to our Bylaws, a quorum is necessary for a vote to be officially enacted. This means that without a quorum, the vote will not be counted. We needed 123 shareholders to establish a quorum. It was noted that a quorum is not required for the budget vote. We validated 52 and found two invalid ballots, making them the only ones submitted from a total membership of 615.

At our first Board meeting of the fiscal year, one of the initial items on the agenda was to fill two of the three vacant seats on the Board, as we did not achieve a quorum at the Annual Meeting. Jim Johnson and Julie Orcutt were appointed to one-year terms. The next item was to select the officers for the Board of Directors. See the results below.
