## Meeting Summary:

- ARCHITECTURAL Nothing to report.
- BUDGET & FINANCE Deadline passed on one of the Jumbo CD's before the money could be moved. Proposal made for next deadline CD of August 17 to be moved to the Money Market account and then to Discover Bank. Board approved.
- COMMUNITY CENTER The front hand rails have been painted.
- CLUBS The Play Group will have a clothing drive August 28.
