New Business

- Maintenance Position Eric
 - Job Description was sent out to all board members with the pay range from \$30.48-\$38.49 hourly.
 - Marci feels that 30 is too high to start a landscaper for our small HOA; should start at 25 and give small increment raises after 90 days.
 - Theresa stated that qualified people may not apply due to low wages. Labor is not cheap, we should be prepared to pay.
 - o 90-day evaluation hold to a standard of work that SLMC expects.
 - Living wage

Committee Reports

- Architectural: David White will have a manufactured home put in on Bona Vista.
- Compliance: Farm animals on a property near the golf course.
- Communications: All articles for the newsletter are due by 10 am on Friday.
- Governance:
 - We have received answers from the attorney regarding the Bylaws, and the committee is working on the policy and procedures for the park. Policy for rental, shelter, boat launch, and the park. We will also include the ballfield & community center rentals.
- Parks The bleachers are in, and the parks committee will put it together Friday for the hydro races and then the bleachers will be anchored down next to the tennis courts.
- Water:
 - CC&R PFAS were listed in the report sent out to the community— PFAS do not disintegrate over time. DOH Water has a page that speaks of PFAS. More information will be given later as the necessary entities provide answers to us. EPA just set a standard last week. PFAS can be treated or filtered.
 - High magnesium & iron levels were high in 2022. Well #6,
 - Meter reads If you have a reading that you feel is inaccurate then call the office so that it can be re-read, at no charge. Going on Facebook does not solve the issue. Booster pumps still aren't fixed.
- Finance Water & HOA profit and loss are current. The increase of 4% in dues will assist in keeping our reserves funded.
- Events:

- o Hydro races on Saturday 10-4, 11-2 activities for kids,
- o May 4 Beautification Day, we will have approximately 86 plants
- o Fishing derby SLAMs will need to ok the camping in the park.
